

## 1. TOURIST VISA APPLICATION PROCEDURE FOR US CITIZENS

A US passport holder who wishes to enter Türkiye for touristic purposes must obtain a tourist visa. You can apply for an *e-visa* on [www.evisa.gov.tr](http://www.evisa.gov.tr). E-visas can be obtained the same day. If you are NOT eligible for an *e-visa*, you must apply for a sticker visa at the nearest Turkish mission to your residence.

### Application Method:

1. Assemble the required documents listed below.
2. Start an online application on [www.visa.gov.tr](http://www.visa.gov.tr) and upload the documents when prompted.
3. Print out the application form. (*Requirement #2*)
4. After submitting the application successfully, schedule an appointment for the interview.

Applicants are required to bring hard copies of the documents on the day of the interview as well.

- **Screenshots will not be accepted. Documents are requested in their original size.**
- **The documents such as travel insurance, flight and hotel reservations must contain the name and surname of the applicant/s.**

### Required documents:

1. National passport or official travel document and copy of the front page with photo.
  - a) with an expiration date at least 60 days beyond the last day of your intended stay.
  - b) with a blank page to affix the visa.
2. The application form
3. One recent passport photo - size (2" x 2")
4. Proof of travel health/accident insurance, valid through duration of stay, including:
  - a) minimum coverage of 30,000 Euros or equivalent USD
  - b) transfer of the patient to nearest healthcare facility or residency address after discharge and transfer of body in case of death,
5. Non-refundable visa fee\*  
Visa fee can only be paid in cash or money order payable to the Turkish Consulate General in NY. Debit, credit and personal checks are not accepted.
  - **Single entry tourist visa: 185.00 USD**
  - **Multiple entry tourist visa: 265.00 USD (valid only for 6 months with a 90-day stay)**
6. Hotel reservation (*These reservations do not need to be purchased yet*)
  - A notarized invitation letter is required if you are going to be hosted.
7. Flight reservation (*These reservations do not need to be purchased yet*)
8. Proof of the existence of material resources in the country of residence;
  - Last 6 months bank account statements. If you provide your company account statements, you must also submit your in your name.
  - Document showing employment; pension or sufficient and regular income.
  - Document showing real estate status.

**Optional:**

9. A pre-paid envelope (mail carrier of your choice) if you would like your visa-issued passport to be returned by mail. (*Turkish Consulate General in NY is not responsible for any delivery issues*)

### Important notes:

- It is strongly advised for applicants to apply at least one month prior to their intended trip.
- In individual cases, the applicant may be required to provide additional documents which may delay the visa issuance.

- Turkish Consulate in New York cannot expedite a visa application.
- Please do not finalize your travel arrangements until you are notified about the outcome of your visa application.
