

3. DIGITAL NOMADS VISA APPLICATION PROCESS

Application Method:

1. Assemble the required documents listed below.
2. Start an online application on www.visa.gov.tr and upload the documents when prompted.
3. Print out the application form. (*Requirement #2*)
4. After submitting the application successfully, schedule an appointment for the interview.

Applicants are required to bring hard copies of the documents on the day of the interview as well.

- **Screenshots will not be accepted. Documents are requested in their original size.**
- **The documents such as travel insurance, flight and hotel reservations must contain the name and surname of the applicant.**

Required documents:

1. National passport or official travel document and copy of the front page with photo.
 - a) with an expiration date at least 60 days beyond the last day of your intended stay.
 - b) with a blank page to affix the visa.
2. The application form
3. One recent passport photo - size (2" x 2")
4. Proof of travel health/accident insurance, valid through duration of stay, including:
 - a) minimum coverage of 30,000 Euros or equivalent USD
 - b) transfer of the patient to nearest healthcare facility or residency address after discharge and transfer of body in case of death,
 - Your contract may suffice if it refers to your health insurance coverage.
6. Non-refundable visa fee
 - Visa fees can only be paid in cash or as money order payable to Turkish Consulate General in NY. Debit, credit and personal checks are not accepted.
Single entry work visa fee: 185.00 USD for US citizens
Multiple entry work visa fee: 265.00 USD for US citizens
 - You may e-mail us to find out the visa fee for non-US citizens.
7. Original and a hard copy of your valid residence permit. (*NON-US applicants only*)
 - US tourist visa (B1/B2) holders can only apply for a work visa at their country of residence.
 - If you hold a different type of US visa, you may e-mail us to check your eligibility.
8. Diploma / Document of university graduation.
9. Acceptance certificate issued by the Ministry of Culture and Tourism. (Start online application on <https://digitalnomads.goturkiye.com>)
10. A work certificate approved by the employer, if the applicant is employed by a company.
11. If the applicant is self-employed, the contract related to the project carried out by the applicant.
12. Employment letter and earning statement and Proof of the existence of material resources in the country of residence;
 - Last 6 months bank account statements.
If you provide your company account statements, you must also submit your Business Certificate in your name.
 - Document showing employment; pension or sufficient and regular income.
 - Document showing real estate status.

After the interview:

- 1- You will receive e-mail from the Turkish Consulate once the processing is complete.
- 2- In case of approval, you will either bring your passport to the Consulate or you will mail it.
 - If you would like your visa-issued passport to be returned by mail, a pre-paid envelope must be added. (*Turkish Consulate General in NY is not responsible for any delivery issues*)

Important notes:

- Your visa will have max. 90-day stay only. You must contact Presidency of Migration Management about the resident permit card which will allow you to stay beyond that period. You may visit <https://e-ikamet.goc.gov.tr> for detailed information about residence permits.
- In individual cases, you may be required to provide additional documents.
- Please do not finalize your travel arrangements until you are notified about the outcome of your visa application.
